

- 1. The SE NRIC logo on the cover page should be replaced by the logo of the SF operator. The word "Template" to be deleted.
- 2. The wording "Annex 19 B to the Network Statement of the railway network of SE NRIC" to be deleted everywhere.
- 3. The Column "Implementation guide" provides instructions on filling in of the information, which is put in the following column "Suggested text After filling in of the template the explanatory text in the column "Implementation guide" to be deleted.
- 4. The column "Suggested text" to be renamed as "SF information" and the information according to the Implementation Guide to be filled in.

- 5. The submitted information should not include any uncertain or inaccurate information, such as: web page www.xxxxxxx, 3X1, 2X, this document is updated yearly at XX of XXXXX, unlessetc.)
- 6. Information on the access conditions to be satisfied by the applicant is provided in item 5.
- 7. Information on the manned of submission of request is provided in item 6.1.
- 8. The priority criteria upon receipt of requests, which are in conflict as well as the way of the answer by the SF Operator about the acceptance and rejection of the request is provided in item 6.2.
- 9. Information on forthcoming changes of the SF technical characteristics and planned temporary restrictions of the service is provided in item 6.3.

When the template is filled in accurately, it should be published at the web page of the SF operator and a link to be sent to e-mails a hristov@rail-infra.bg and b georgiev@rail-infra.bg, which will be published by SE NRIC in an Annex to the Network Statement.

The operators not having a website should provide the filled in template ready for publishing (in electronic format: text format ".doc")
